1.1 Industry Background



1.2 Blockchain Technology Development

Blockchain technology has come into the public eye due to *Bitcoin* and has won the favor of many companies for its significant technical

advantages. Take bookkeeping as an example, in the past, bookkeeping was done by a certain agency, but in the blockchain era, distributed bookkeeping relying on consensus mechanism has become possible, and its advantage is tamper-proof. Blockchain technology is a technical solution that enables all participants in a system to collaborate, record and maintain a reliable database under the condition of multi-agent and without mutual trust, through decentralization and cryptography technology. Blockchain technology enables any number of agents involved in the system to calculate and record all information exchange data in the system over a period of time into a data block through cryptographic algorithms, and generates the data block password, which is used to link and verify the data block in the data chain, while all participants and agents in the system can jointly determine whether the record is true or not. Blockchain technology enables trading parties to establish stronger mutual trust without the need to go through an agency, thus significantly reducing trading costs, enhancing trading security and improving transaction efficiency.

Blockchain is a term used in the information technology field. In essence, it is a shared database in which data or information is stored with features such as 'tamper-proof', 'traceable', 'open and transparent',

However, in the existing online games, the algorithm of core data such as the content, quantity and extraction probability of these virtual props and equipment are centralized and managed style, which cannot be done completely openly, leading to a great impact on the playability aspect of the game.

○ Transparency

In traditional game entertainment project, game maker or project owner have absolute dominance, when game maker/project owner change the game rules, users can only choose to passively accept. In addition, many algorithms within the game are not transparent and cannot guarantee fairness.

○ Circulation

With the continuous development of the game market, the security of game virtual property is highly concerned. Cases of theft and hacking in game virtual property trading frequently happen, causing great losses to users. What's more serious is that, as the game items are issued by a certain game company. Game items are locked in a certain game, with the demise of the game, all the game property of users, money, time and energy invested will vanish.

1.4 Advantages of Blockchain+

The blockchain system has profound guiding significance for the current situation of the game industry, and blockchain technology has great application potential in the game field. The combination of game digital assets with blockchain will bring a revolutionary change to the game industry, and an era of game digital assets is coming.

○ **Transparent and Trustworthy Information**

The game industry generates a large amount of game assets every year, all of which are centrally operated by game developers or publishers. Blockchain brings us a decentralized way to issue assets, allowing users the ownership of game assets, also, the related information about the asset issuing method and total amount can be monitored. Using the open and tamper-proof nature of the blockchain transaction ledger, blockchain games can open all data online, and users can check wanted evidence. 3.3 STAKING


